Resulting in findings with some of our products that were damaged on their way to the customer.</p> <p>To reduce the risk of module damages during shipping/ handling Gemalto takes immediate action for above mentioned products.</p> <p>Hence Gemalto reduces the number of modules per reel from 500pcs. to 400pcs.</p> <p>Given this change the minimum order quantity of said products changes from 1.000 pcs. to 800 pcs. Customers are kindly asked to adjust order volumes to this granularity.</p> <p>The below mentioned date of introduction is the date by when all above products will have been changed the latest to 400pcs./ reel.</p>
